**GUIDELINES & DATELINE FOR LL.M VACANT SEAT ADMISSION UNDER
SAMS, ODISHA FOR THE SESSION-2022-23**

As per the H.E. Letter No.-45064//Dated 29.10.2022, the following Guidelines and dateline for LL.M vacant seat admission under SAMS, Odisha for the Academic Session- 2022-23 is given below.

- 1) CPET-2022 appeared candidates will only eligible to participate in the Vacant Seat Admission round.
- 2) Those have taken CLC/ULC for any reason, during the Phase-1 (1st, 2nd & Spot Round) of LL.M Admission will not be eligible in this round.
- 3) Candidates are eligible for the subject(s) in which he/she had appeared the entrance Examination (CPET-2022). Subject wise eligibility criteria will remain intact as per the Common Prospectus-2022. Earlier entered option will not be considered for LL.M Vacant Seat Admission.
- 4) A correction window will be opened for the following categories of candidates to correct the previously submitted CAF, such as:
 - a) Those who have not uploaded the graduation mark or failed to mark Distinction in the CAF.
 - b) Those who have not marked their reservation category or wrongly marked reservation category.
 - c) Those who have wrongly provided their marks after conversion of CGPA to Percentage or other Boards such as CBSE, ICSE etc. After correction of their data online in CAF, all such candidates are advised to follow the process mentioned in the **Point No.-6**
- 5) Weightage marks will not be considered in this round. Hence, a separate mark calculation list will be published at SAMS Website by taking CPET Mark and Career Mark of the candidates.
- 6) Candidates are advised to take printout of the common application form (CAF) and report in the College along with the relevant documents and revised marks (Career+Entrance) for participation in Vacant Seat Admission round as per the schedule.
- 7) Selection will be done on merit (Career Mark + CPET Mark) only.

8) Merit list shall be displayed in the institution's websites and notice boards.


9) In absence of the reserved category candidates, colleges may de-reserve the seats at their level to take suitable candidates against those seats.

- 7) Adhaar Card (Xerox copy)
- 8) Migration Certificate in Original.
